### **6th Doctoral Workshop: Cooperation, Exchange and Solidarity in Europe 1945-1990 (August 26-29, 2000)**

### **7th Young Scholars Forum on Central and South East Europe "European narratives - in search for common diversity" - Vienna, 2-6 December 2020**

Europeans face Europeans. The national policies of the states making up the old continent continue to shape Europe's future at the expense of Europe as whole. The divisions among the countries are deepening, very often in a way that creates a crisis both internally and in a global context. The constant search of common narratives - as the basis for a common identity-based policy - seems to be increasingly difficult in the face of fragmented political spectrum and ever-more differing policy approaches in Europe. ### **Memories of Transformation, Transformation of Memories. Remembering the Post-1989 Era in Germany and Central and Eastern Europe, VS Verlag für Sozialwissenschaften**

Who "owns" the memory of the post-1989 period in formerly East Germany? In this volume, we seek to bring together perspectives from the social sciences that illuminate the background conditions of these developments. The core argument is that, today, the period post-1989 has itself become a space of memory. Key experiences of the 1990s - at work, in the family, in interpersonal relations - are narrativized and imbued with meaning. In this volume, our aim is to take the period post-1989 seriously as a space of experience and social memory. We seek to go beyond a limited understanding of references to this time as a source of political cynicism and resentment - but we do want to systematically map and examine the ways in which this period is imbued with meanings that inform reactionary, nationalist, and anti-liberal views today. ### **Tvrtko Jakovina, Martin Previšić (eds.), *The Tito-Stalin Split 70 Years After* (Odsjek za povijest Filozofskog fakulteta Sveučilišta u Zagrebu - Oddelek za zgodovino Filozofske fakultete Univerze v Ljubljani, Zagreb - Ljubljana, 2020)**

U izdanju Odsjeka za povijest i Poslijediplomskog doktorskog studija Moderne i suvremene hrvatske povijesti u europskom i svjetskom kontekstu Filozofskog fakulteta Sveučilišta u Zagrebu i Oddelka za zgodovino Filozofske fakultete Univerze v Ljubljani objavljen je 2020. zbornik radova "The Tito-Stalin Split 70 Years After" koji su uredili Tvrtko Jakovina i Martin Previšić na osnovu istoimene konferencije održane u Zagrebu 2018. povodom 70. godišnjice sukoba Tita i Staljina 1948. godine. **Vedran Duančić, *Geography and Nationalist Visions of Interwar Yugoslavia* (Palgrave Macmillan, 2020)**

This book is the first historical work to examine the notion of national territories in Yugoslavia – a concept fundamental for the understanding of Yugoslav history. Exploring the intertwined histories of geography as an emerging discipline in the South Slavic lands and geographical works describing interwar Yugoslavia, the book focuses on the engagement of geographers in the on-going political conflict over the national question. Duančić shows that geographers were uniquely equipped to address the creation of the new country and the numerous problems it faced, as they provided accounts of Yugoslavia's past, present, and even future, all of which were understood as inherently embedded in geography. **Maria Todorova, *The Lost World of Socialists at Europe's Margins: Imagining Utopia, 1870s - 1920s* (Bloomsbury, 2020)**

Maria Todorova's book is devoted to the 'golden age' of the socialist idea, broadly surveying the period in and around the time of the Second International. It critically examines the promise for an alternative socialist utopia from 1870 to the 1920s. Todorova brings in the experience of the periphery in a comparative context in the belief that the margins can often elucidate better the character of a phenomenon, and de-provincialize it from essentialist notions. In doing so, *The Lost World of Socialists at Europe's Margins* moves beyond the traditional historiographical emphasis on ideology by looking at different intersections or entanglements of spaces, generations, genders, ideas and feelings, and different flows of historical time. **One year scholarships, BAYHOST**

The Free State of Bavaria invites applications for its one-year scholarship program for students from Central, Eastern and Southeastern Europe for the academic year 2021/22 via BAYHOST. Graduates from Bulgaria, Croatia, the Czech Republic, Hungary, Poland, Romania, Russia, Serbia, Slovakia and Ukraine are eligible to apply. The scholarships are meant to finance postgraduate studies (i.e. master's programs) and PhDs at Bavarian higher education institutions. Annual scholarships can be extended twice for up to 3 years; the scholarship amounts 853,-€ per month. One-year study sojourns in Bavaria as part of a PhD in the home country can also be funded.
